Well I'm back again this month putting out an improvised newsletter as F Co continues to look for a new editor for the newsletter. The major event for March is the Fort Work Day to prepare the site for the upcoming April Camp of Instruction. See the following.

Fort Work Day (Sat, 4 Mar 2017)- Everyone should be on site by 0900 and plan on working till around 1300-1400 hours. Primary work effort will be cleaning outhouse; movement of rotted oak planking; filling in powder magazine site; replacement of hardware and lanyard on flagpole; and general pick-up/clean-up in the interior of the Fort including brush clearing. This work fulfills our mission of both preparing for the COI, but also continued preservation of this historic Confederate earthen fortification. Remember this work effort is based on the 9 individuals who signed up, so be there!

Everyone needs to wear work clothes including work boots, long trousers and leather work gloves as your being exposed to brush and briers and possibly even ticks given the recent warm weather. You need to bring a quantity of water along w/any snacks or food that you want.

We need all participating members to supply the necessary work tools including brooms and dust pans for cleaning the outhouse. Other work efforts require machetes, axes and hatchets, brush hooks, heavy pruning hooks and loppers, wire cutters and fencing tools. Specifically we need shovels, picks and pick mattocks and heavy rakes for moving dirt and spreading into the powder magazine site. If in doubt bring it! If you leave it at home it ain't going to do us any good!

When arriving everyone needs to closely follow the dirt road around the farm fields to the Fort. Park you vehicles in an orderly manner at the entrance to the Fort. Directions to site:

Take I-295 exit, Exit 84B, toward Charlottesville

Take US-1 S exit on the left toward Richmond

Merge onto I-295 N via exit on the left toward I-64 W/Charlottesville

Merge onto I-64 W via exit 53A toward Charlottesville

Merge onto VA-288 S via exit 175 toward Chesterfield

Merge onto US-60 toward Powhatan

Turn left onto Dorset Rd.

Dorset Road becomes Schroder Rd.

Schroder Road becomes Genito Rd.
Genito R. becomes VA 604 Chula Rd. Continue to follow Chula Rd.
Turn left onto Coverly Rd.
As you cross railroad tracks look for F Co directional signs

From I-95 North:

I-95 North
Merge onto VA-288 via exit 62 toward Chesterfield/Powhite Pkwy.
Merge onto US-360 W toward Amelia CH
Turn right onto Chula Rd.
Turn right onto Coverly Rd.
